Sir,

With reference to your application on the subject noted above, I am directed to convey the approval of Director of Education, Delhi to grant recognition to your school class Ist to VIII (without aid) w.e.f. 1.4.90 session subject to the fulfilment of the following terms and conditions:

1. That the school shall abide by the provisions of Delhi School Education Act and Rules, 1973 framed thereunder as well as the students issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of Rohini Area.
3. That the provisions of sec. 10(i) of DSEA, 73 shall be fulfilled.
4. That adequate sports material shall be purchased and made available to the students immediately.
5. That the school shall strictly abide by the provisions of Delhi School Education Act and Rules, 1973 and payment shall be made as per section 10(i) of DSEA, 1973 and to all employees.
6. That the enrolment in each section shall not exceed the number of students calculated @ 12 sq.ft. per students for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class. Number of the existing sections should not exceed the number of the class-room of proper size in the school.

7. That the school shall dispense with the services of unqualified and over-aged staff, if any immediately.
8. That all the facilities prescribed under Rules 50 and 51 of the DSEA, 1973 shall be made available to the students. Provision of Rules 6, 7 and 8 be strictly observed.
9. That the arrangement of good drinking water shall be made available to all the students as well as the teachers.
10. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawal of recognition of the school.
11. That the class IX shall not be opened without the prior approval of the Director of Education, Delhi.
