In the circumstances reported by the Registrar (Administration) FAC Registrar (Recruitment), High Court for the State of Telangana at Hyderabad in the letter 2<sup>nd</sup> read above, the Government of Telangana, after due verification and detailed examination, hereby approve the selection of (66) randidates specified in the Annexure appended to this order and appoint them as Civil Judges with the following conditions:
